Here's how it works . . .

Several weeks after we receive the submission an electronic PDF proof copy is posted. Soon after it is approved by the author the work is offered for sale at the Universal Publishers internet site and becomes available by special order through thousands of booksellers world wide.

Most books are priced starting at \$19.95 in paperback and \$6.00 in downloadable PDF edition. Authors get a 20% royalty when the paperback version is sold through bookstores, 40% when the paperback purchased directly from upublish.com, and 40% on sales of the electronic PDF version of their book. (See table below.) Author royalties are paid quarterly and apply to all sales of the work after the first three copies sold in each calendar quarter. (continued on reverse side)

Publishing Procedure

- 1 Submit Book Proposal from Publisher's website.
*** **IF ACCEPTED** ***
- 2 Combine your manuscript into a single computer file.
- 3 Place all your graphics and format exactly the way it should appear in print.
- 4 Save in a popular PC word processing program (or Adobe PDF format and save \$100).
- 5 Save the synopsis in a separate text file.
- 6 Complete Submission Form on-line at Publisher's website and submit electronically.
- 7 Sign and fax Publishing Agreement to 561-750-6797.
- 8 Authorize publishing fee with credit card on-line, or send payment by check to address below.
- 9 Upload manuscript file from special link at website.

Electronic Documents

Each work is made available as an Adobe Acrobat Portable Document Format (PDF) file. An Acrobat PDF file can be sent electronically over the internet and viewed exactly as it appears in print. Adobe distributes the Acrobat Reader free of charge from its web site at Adobe.com. With the Acrobat Reader, the PDF file and the password obtained from Universal Publishers, anyone can read the work on their computer.

Users can also perform full text searches with PDF files. Full text searching allow a user to locate specific words or sentences in your document, making research and citation faster and easier. The first 25 pages of each work are made available on-line for anyone to browse. In order to control distribution a password is required to view the entire publication.

Publishing Agreement

Universal Publishers (the Publisher) agrees to assign a publisher's ISBN and offer the work for sale. The Publisher agrees to pay the author a royalty of twenty percent (20%) on sales of the work after the sale of the first three copies sold in each calendar quarter when ordered through a bookseller at our standard discount, and forty percent (40%) on all sales after the sale of the first three copies in each calendar quarter when purchased from the Publisher at the retail price. Royalties are payable 45 days following the end of each calendar quarter. The Publisher agrees to cease distribution of the work within 90 days upon written notification by the author. Universal Publishers reserves the right to reject any submission for any reason.

I represent and warrant to Universal Publishers the content of the manuscript submitted is my own work and that I do not infringe or violate the rights of anyone else and that I am the sole owner to the rights to this work. Furthermore, I understand that it is my sole responsibility to obtain any copyright permission necessary to publish my work.

I hereby grant Universal Publishers the limited, non-exclusive right to reproduce and distribute, in whole or in part, my work indicated on Submission Form in both hard copy and electronic form. I agree that either party may terminate this agreement for any reason, at any time, by giving 90 days written notice (initial fees are non-refundable). I agree that any changes to my work after it is accepted for publication by the Publisher represent a new submission and may require repayment of all submission and preparation fees. It is my responsibility to notify Universal Publishers of changes in my email and mailing address.
